Unfortunately for Bob, he found out that not only is cocaine very addictive, it has the ability to destroy your life. His employer at the time didn't know what to do with him, as his performance had greatly dropped off; he had almost 50 meetings to discuss the situation, all without involving Bob. In fact, the only meeting Bob had with his employer was when they let him go. This moment convinced Bob to seek treatment, and since this point in his life, he has involved himself heavily in the cause to change the stigma around substance use disorder and give others hope for recovery.
